1. Which are the main topics of interest for social scientists in your country?

Gender, crime and deviance, livelihood empowerment, work and occupation, sexuality and sex, and medical sociology.

2. How do you describe a typical student from your country?

DID YOU ENCOUNTER ANY DIFFICULTIES?

I was in the third year of my PhD when I decided to apply for the Fulbright program. My study plan is to submit my thesis at the end of the fourth year. At that time, I was looking for an opportunity which could academically and financially support the final year (i.e. the fourth year) of my PhD. I also found that my study and career plans fit extremely well with the aim of the Fulbright Program in Hong Kong. I therefore believe it would be exciting and helpful to spend the final year in the US to deepen the analysis of my project and write up the thesis.

WHY DID YOU APPLY TO THE FULBRIGHT PROGRAM?

CAN YOU TELL US MORE ABOUT THE APPLICATION PROCESS?

The process takes quite long. The deadline for submission of the application was October 2018, and I got the official offer in May 2019. It thus took more than seven months. In general, there are two main steps. First, the submission of the application through the online system. Second, the face-to-face interview. For the former, the most important documents are "research objectives" (you describe your research project for studying in the US) and "personal statement" (you describe yourself). For the latter, I was interviewed by five interviewers (including four professors and one American Consulate officer). The interview lasted around 15 minutes, and the main questions were about my research, and why I would like to go to the US with the Fulbright program.

Since I know the program is competitive.

The main difficulty was not practical issues, but was the mental pressure. I still remember how stressed and nervous I was before the interview, but it was really wonderful that I had the chance to chat with my supervisor, friends and family when I felt stressed during the whole application.

WHAT ARE YOUR EXPECTATIONS?

For my time in the US, I have two aims: First, to develop the analysis of the empirical chapters of my thesis and take my research to the next level. Second, to equip myself with the necessary expertise in conversation analysis and video analysis, so that I can bring this methodology to China where I hope to pursue an academic career in the near future. By studying in the US, I will be based at one of the foremost centres of video analysis or conversation analysis in the world—Center for Language, Interaction, and Culture (CLIC) at UCLA. I will be working under the supervision of Prof. Tanya Stivers, who is the President for the International Society for Conversation Analysis.
