







Department of Sociology, The Chinese University of Hong Kong Professor Yeung is a Provost-Chair Professor in the NUS Sociology Department and Yong Loo Lin School of Medicine. Prior to NUS, her academic history includes time at the University of Michigan and New York University. She is the founding Director of the Center for Family and Population Research in the Faculty of Arts and Social Sciences at NUS. She is an international advisor for several family panel studies in the world. Currently, she leads a project on Singapore preschool children's development - Singapore Longitudinal Early Development Study (SG LEADS). Professor Yeung has published extensively and has been on the editorial boards of several top-ranking international journals such as Demography, Journal of Marriage and Family, Child Development, Social Science Research, and Journal of Family Issues, and on numerous scientific review committees and advisory boards. Professor Yeung's current research includes various family demographic issues in Asia and in America. Her work appears in leading journals and is cited widely in academic publications and high-impact media such as BBC News and The Economist. Her recent publications include changing family values and behavior, children's well-being, human capital, and aging.

#### Abstract

Being theorized as one of the global cities, Hong Kong has long prided itself as a cosmopolitan city bridging China and the World and capitalized on such a self-positioning. At the same time, Hong Kong people have formed a deep sense of local identity revolving around the specific history, culture, and ethos of the city. Hong Kong's simultaneous situatedness between the local and the global has created both opportunities and tension for sociologists, who are sometimes torn between the dilemma of wanting to conduct research of local relevance and aspirations to speak to a global academic community. Could the local and the global be productively combined to generate knowledge that is relevant for both the local and global audience? If so, how could this be achieved amid a time when Hong Kong society is undergoing rapid social changes? This panel invites three generations of sociologists to share their thinking on this issue, their strategies of conducting sociological research on Hong Kong that simultaneously attends to the issues of the local and speaks to an audience of the global, and their reflections on future paths ahead.






